一、다음 문장을 중국어로 옮기십시오.

- (一) '강남스타일'은 울퉁불퉁한 모습의 30 대 아저씨가 뭔가 방정맞고 상스럽기까지 한 몸짓으로 자기 자신을 희화화했다. '강남스타일'은 인간 본성엔 고상하고 고급스러운 것을 추구하는 욕망과 더불어 쉽고 재미있는 것에 더 가까이 다가가려는 성정도 들어 있다는 점을 과고들었다. 제작진은 제작 과정에서 "개그 감각과 익살스러움 그리고 중독성을 높였다"고 설명했다. 싸이와 '강남스타일'에 관련된 트위터에는 '재밌다' '신기하다'는 글이 8 억개 이상 등장했다. 유튜브 조회 1 억건 가운데 북미·남미·유럽의 조회가 48%나 됐다. 그들에게 '강남'이라는 문화 코드는 생소했겠지만 언어 장벽을 넘어서는 만국 공통 코드인 '신기'와 '재미'가 마음을 열게 했다. 강남스타일의 말춤 동작엔 종래의 K 팝과는 달리 한국만의 토속적인 맛이 있다는 점도 성공 요인일 것이다. - (二) 해방정국의 사회상은 각종 정파의 난립, 치열한 주도권 쟁탈, 좌·우 이념 세력 간의 살벌한 대립관계, 정상배와 모리배들의 횡행, 한탕주의 풍조의 심화현상, 윤리의식의 난파, 전재민(戰災民)이나 월남민(越南民)과 같은 뿌리뽑힌 자들의 급증, 국민경제의 파탄 등으로 요약된다. 이 기간에 발표되었던 소설들은 일제의 포악함과 당시 한국인의 참혹한 삶의 실상을 드러낸 것, 죄의식을 바탕으로 해 일제 때의 자신의 행위를 비판한 것, 해방을 맞아 고국 또는 고향으로 돌아오는 사람들의 모습을 그리는 가운데 당시 한국인들의 '뿌리 없는' 삶의 형편을 강조한 것, 38 선이 그어진 현실을 불안감과 단절감을 강조하며 주시한 것 등으로 나누어진다. - (一)心靈貧窮，指的就是感情冷淡、心思狹窄的意思。遇到好玩的事情，不懂得開懷大笑；碰到讓人痛苦傷感的事情，也不會悲傷難過；即使身旁有個可愛的人或討喜的動物，也不知如何表達愛意。設法讓這種冷淡的、閉鎖的心緒打開，就是使得心靈成為富翁的途徑之一。譬如，懂得珍惜身邊寶貴的東西，也能適時地對該感謝的事情表示謝意，甚至也知道對自己的缺點表示厭惡，都是促使你的心靈成長，成為心靈富翁的一種途徑。(15分)
- (二)在阿里山山區觀賞日出的絕佳地點，即為祝山。新建的幾處觀景平臺腹地廣、視野佳！前往祝山觀日有兩種選擇，一是由阿里山火車站搭乘祝山觀日火車，單程約 25 分鐘，鐵道盡端的祝山車站就是臺灣海拔最高的火車站。或者，另走祝山觀日步道，步道自沼平公園觀日步道牌樓拾階而上，步程約 40 分鐘。(15分)
- (三)韓國經濟若想擺脫企業差距擴大帶來的風險，就要在其他領域培養企業，使其在未來成長為三星電子、現代汽車集團那樣實力雄厚的企業。大企業本身也要努力增強競爭力和核心實力。政府要培養更多具有競爭力的中小企業，改善制度使經濟實現均衡，並提出政策支援的新方向。韓國經濟的向前發展不能只依靠三星和現代兩個大企業來拉動。(15分)
